- A baseline study to provide a factual record and analysis of the current nature and value of the landscape and visual amenity in the area.
- A systematic prediction of the effects that are likely to occur and description of their nature.
- Proposals for measures designed to for avoid, reduce or compensate for any negative effects or enhance positive effects.
- Systematic and transparent evaluation of the evaluation of the effects that remain after mitigation has been incorporated into the scheme proposal.
- For larger developments community consultation may be required.
- Presentation of the findings of the LVIA in written and graphic form.
- Review of the findings to identify any required amendments.
